

REGIONAL SPOTLIGHT: LA PLATA COUNTY

In Southwestern Colorado, Durango still maintains its vibrant agricultural roots. CSU Extension of La Plata County plays a key role in encouraging food security and accessibility to all demographics of the area.



County Director Darrin Parmenter has worked for Extension since 2003, moving back to his hometown of Durango in 2007. His work at Extension covers a wide variety of events and projects, but all of them uphold the mission that he and his colleagues share: public education and advocacy for local food systems. Parmenter said, “Food is something easy that we all can get behind in the office, something we can all hang our hat on.” One of their most successful projects partners with The Garden Project. As one of the top programs in the country, the school gardens not only supply the cafeterias, but local soup kitchens as well. Local beef is also served in school lunches, thanks to an event called Food Retreat.

Starting in 2008-2009, this annual event builds relationships between farmers, restaurants, and other buyers through conversations, keynote speakers, and workshops. Extension additionally assists in balancing wildlife populations and agriculture.



In an effort to reduce bear-human interactions and reduce the fruit load from urban apple trees, Durango Apple Days was created in cooperation with the City of Durango, La Plata County, and CSU Extension. 4,000 to 6,000 pounds of fruit is gleaned from apple trees in the county and then pressed into about 250 gallons of juice during the festival attended by almost 1,500 visitors. The success of these events and many others can be attributed to support from the community and partnerships with other organizations. Growing Partners of Southwestern Colorado, Bear Smart Durango, Durango Farmers Market, USDA, school district administration, farmers, ranchers, volunteers, and community members all make food nutritious and accessible to everyone in

the area by, “working together and sharing the burden,” Parmenter emphasized. 

GRANTS: PORTABLE FARM STORAGE AND HANDLING EQUIPMENT

Portable equipment can help producers, including small-scale and local farmers, get products to market quickly, and the impact of access to such capital is now understood. To support this activity, USDA's Farm Service Agency (FSA) will provide a new financing option to help farmers purchase portable storage and handling equipment. The loans, which now include a smaller microloan option with lower down payments, are designed to help producers, including new, small and mid-sized producers, grow their businesses and markets. Farm Storage Facility Loans can also be used to finance wash and pack equipment used post-harvest, before a commodity is placed in cold storage!

GRANTS: FARM TO SCHOOL GRANT PROGRAM

The purpose of the USDA Farm to School Grant Program is to assist eligible entities in implementing farm to school programs that improve access to local foods in eligible schools. On an annual basis, USDA awards up to \$5 million in

competitive grants for training, supporting operations, planning, purchasing equipment, developing school gardens, developing partnerships, and implementing farm to school programs.

Applications are due by December 8th by 11:59PM EST and we encourage those producers, communities and organizations supporting farm to school to apply! For more information click [here](#).

GRANTS: MARKETING MATCHING GRANT PROGRAM

The Colorado Tourism Office is offering a matching grant program to support marketing efforts within the tourism industry. Travel regions throughout the state are eligible for grant funding, as well as statewide associations, organizations and other nonprofit entities that engage in promoting travel throughout the entire state.

One example that was funded in the past is the Colorado Historic Hot Springs Loop, a 722-mile driving route that leads visitors to 19 hot springs attractions in Colorado. The Loop was created by DMOs in Glenwood Springs, Ouray, Ridgway, Pagosa Springs, Chaffee County and Steamboat Springs.

GRANTS: EXTENSION RISK MANAGEMENT EDUCATION PROGRAM

The Western Extension Risk Management Education Center (Western Center), in conjunction with the Northeast, North Central and Southern Centers, announce a funding opportunity for projects that help farm and ranch families succeed through targeted risk management strategies. The maximum amount of requested funding shall not exceed \$50,000 for Education Projects and \$2,000 for Exploratory Projects. This is a program where CSU personnel can partner with producers and communities, so please reach out to CSU if you need a collaborator.

1. Food Systems Hub “Hublet” Application

Application Due Date: Friday October 21, 5 p.m.

Overview: The [Colorado Food Systems Hub](#) is a community resource designed to support healthy, resilient food systems across the state by providing relevant, reliable data—including enhanced mapping and reporting—in a collaborative environment that promotes peer-to-peer learning to increase impact and effect change. This Hub was

Organizations can readily create Hublets (or Sub-Hubs) organized around place, theme, or issue, and link them to their parent Hub. Hublets have access to all the tools and resources in the parent Hub—in this case, the [Colorado Food Systems Hub](#). Hublets are helpful when engaging a coalition or a community group seeking more focused collaborative spaces. These hublets offer a governance and management framework for engaging regional or topical networks and can connect individuals and communities, intermediary organizations and potential funders.

NEWS: FREE PH TESTING FOR COTTAGE FOOD PRODUCERS


Free equilibrium pH testing of pickled fruits and vegetables is now available to Colorado Cottage Food producers through the Laboratory Services Division at the Colorado Department of Public Health and Environment. Samples can be dropped off or shipped to the lab, or left at one of the free courier pick up locations.

We encourage you to promote this free service to producers that hope to validate their standardized, personal, or family recipe(s) for pickled fruits and vegetables and verify a finished equilibrium pH of 4.6 or below. A producer may submit up to five different products for free equilibrium pH testing. Results will be mailed directly to them and will confirm if their recipe is just right or prompt them to make adjustments to assure the safety of their product for their customers.

Samples will be collected and processed on a first come, first serve basis. Funding is limited so please encourage producers in your area to take advantage of this free opportunity. Colorado Proud School Meal Day took place on September 14th with the help of Colorado Department of Education, The Western Dairy Association, Colorado Beef Council, Slow Food Denver, LiveWell, CSU Extension 4-H Youth Development, Colorado Foundation for Agriculture and Colorado Egg Producers. An estimated 550 schools participated with 2,199 classrooms and 160,704 students (last year 100,000 students participated).
