REGIONAL SPOTLIGHT: JACKSON COUNTY

Jackson County may have a short growing season, but the local Extension office still finds ways to contribute to and improve its local food system. The main way that Extension does this is through the 4-H program. Debbie Alpe, County Director for Jackson County Extension, said that this program makes a significant impact on the frozen meat supply in the area.

"When our grocery store closed several years ago, we basically became a food desert." Since then, a new grocery store and other food suppliers have increased food availability in the area, but 4-H animal projects continue to be a steady source of meat for the community. Eighty-four students enrolled in 4-H this year and raised twenty-one beef, thirty-five pigs, eight lambs, ten goats, eighteen rabbits, fourteen turkeys, and five ducks. The animals were bought by local community members through private treaty direct sale or junior livestock sale, delivered to meat processors, and then returned to the buyer.

County Extension In some cases, however, the buyer has decided to donate the animal or meat back to the 4-H member or community. In recent years, the local stockgrowers' and cattlewomen's groups have participated in this "buyback" program and donated a full beef to the local school district. Extension's impact through 4-H also extends beyond food production.


Thirty-two 4-H members also participated in Meat Quality Assurance educational activities and learned about live ultrasound, meat judging, and other aspects of livestock care. Debbie's involvement in 4-H grew over the years as her children joined the program. Her favorite aspects of her twelve years in Jackson County Extension are learning about livestock, staying involved and bettering her community, and working for an organization that plays to everyone's strengths. She shared that "Jackson County 4-H is proud to be contributing to a small but much appreciated locally-based food system by producing these high quality meat products." GRANTS: NATIONAL FARM TO SCHOOL NETWORK SEEKING APPLICATIONS FOR 2017-2019 CORE PARTNERS

The National Farm to School Network (NFSN) is seeking partner organizations across the United States to serve as Core Partners during 2017-2019 in the next phase of farm to school and early care and education (ECE) growth and evolution.

The NFSN is looking specifically for Core Partners who will contribute to network development, information sharing, and policy development. NFSN will support the activities undertaken by Core Partners through structured opportunities for peer learning and integration of on-the-ground activities into a coordinated national movement across the United States.

Core Partners will demonstrate the ability to accomplish the following:

- Development of a robust, multi-sectoral farm to school and ECE network in one state,
- Leverage policy opportunities to advance farm to school and ECE,
- Secure agency support through farm to school and ECE coordination positions/responsibilities and dedicated funding,
- Identify additional and diversified sources of funding for farm to school and ECE, and
- Provide equitable access to farm to school and ECE information and resources for all children and communities

Grant awards range from \$4,000 to \$12,000 based on need and farm to school and ECE growth potential over the 2017-2019 timeframe.

GRANTS: USDA SUPPORT FOR LOCAL FOODS SECTOR

The U.S. Department of Agriculture's (USDA) Agricultural Marketing Service (AMS) today announced the availability of \$27 million in grants to fund innovative projects designed to strengthen market opportunities for local and regional food producers and businesses.

The request for applications for the Farmers Market and Local Food Promotion Program includes Farmers Market Promotion Program (FMPP) and Local Food Promotion Program (LFPP) grants, and the Federal-State Marketing Improvement Program (FSMIP). These programs and other resources across USDA are helping to revitalize rural America by supporting local and regional food stakeholders.

AMS will host a webinar for potential FMPP and LFPP grant applicants on Wednesday, February 15, 2017, at 2:30 p.m. Eastern Time, and a teleconference for potential FSMIP grant applicants on Thursday, February 16, 2017, at 2:30 p.m. Eastern Time. BLUEPRINT FOR COLORADO FOOD AND AGRICULTURE

CSU is part of a team of partners formulating a Blueprint for our state's food and agriculture system over the coming year, and we are inviting all Coloradans to be a part of this effort.

The purpose of formulating a Blueprint is to:

- Continue conversations about Colorado agriculture;
- Highlight connections of food and agriculture and its impact across the state;

- Bring Colorado's regions together around shared economic, community health, and food system opportunities and strengths; and
- Frame priorities and levers that will motivate research and programming or inform policy-making across all sectors of the food value chain.

Who should be involved: Those whose lives are touched by food and agriculture. We are hoping to hear from stakeholders along the supply chain (from the natural resources base through to consumers), no matter their scale including consumers, farmers, ranchers, processors, retailers, and food policy groups. Our goal is to get a diversity of voices to the table, recognizing that we will also be hosting commodity specific meetings later in the year.

NEWS: USDA PROVIDES NEW COST SHARE OPPORTUNITIES FOR ORGANIC PRODUCERS AND HANDLERS

The USDA announced on December 21st that, starting March 20th, 2017, organic producers and handlers will be able to visit over 2,100 USDA Farm Service Agency (FSA) offices around the country to apply for federal reimbursement to assist with the cost of receiving and maintaining organic or transitional certification.

According to FSA Administration Val Dolcini, "USDA is committed to helping the organic sector grow and thrive through a wide variety of programs, and part of that commitment is making it easy for stakeholders to access our services. That's why, starting March 20th, producers will be able to visit their local FSA offices to access organic certification cost-share reimbursements for up to 75% of the cost of organic certification. This will provide a more uniform, streamlined process nationwide; and it will give

organic producers a chance to learn about other valuable USDA resources, like farm loans and conservation assistance that can help them succeed."

This is in response to the USDA's effort to encourage participation in the National Organic Certification Cost Share Program (NOCCSP) and the Agricultural Management Assistance Organic Certification Cost Share Program, while also providing more opportunities for organic producers to access a larger range of USDA programs, such as disaster protection and loans for farms, facilities, and marketing. NEWS: OREGON STATE RELEASES MARKET RESEARCH FOR MARKET READINESS PROTOCOL

Oregon State University has recently released its Market Research for Market Readiness (MKTRD) Protocol. This tool is designed to help entrepreneurial food makers and value-added producers evaluate the products they are developing for market, and allows them to:

- Evaluate a product's sensory qualities,
- Investigate how much consumers will pay,
- Get new marketing ideas, and
- Demonstrate market readiness for retailers and investors.

Since this test is conducted by the individual themselves, it will cost much less than professional testing. The materials include a manual, and Excel workbook, and several training videos. 1. Trainings on the Produce Safety Rule under the Food Safety Modernization Act:

This full day program is being offered to 35 participants for a fee of \$100 (includes lunch and training materials) The course will satisfy the Food Safety Modernization Act (FSMA) Produce Safety Rule requirement outlined in subsection 112.22(c). 2. Training on the FSPCA Preventative Controls Rule for Human Food:

February 1st to February 3rd at the Adams County Extension Office, 9755 Henderson Rd, Brighton, CO. The new FDA Preventive Controls for Human Food rule is intended to ensure safe manufacturing/processing, packing and holding of food products for human consumption in the United States. The regulation requires that certain activities must be completed or overseen by a "preventive controls qualified individual." One way to meet the requirements for a "preventive controls qualified individual" is to complete the Food Safety Preventive Controls Alliance (FSPCA) Preventive Controls for Human Food Course. This course, developed by the FSPCA, is the "standardized curriculum" recognized by FDA. It will feature examples relevant to produce packinghouses covered by this rule; however, fresh-cut produce operations and other food facilities will benefit from this course, as well.
