Membership: <u>Membership</u> in Zeta Chapter also enrolls you as a member of the national ESP organization, and a member of the Joint Council of Extension Professionals (JCEP). Discover more about <u>JCEP</u>.

Mentorship: There are times in each of our careers when we can use the consultation and advice of someone who has "been there and done that." If you have been with Colorado State University Extension at least two weeks, you have likely already connected with one of our members, whether you realized it or not. We are dispersed across Colorado and our members have the experience and institutional knowledge that is valuable to new CSU Extension employees. Additionally, many of us have gotten to know colleagues in other states through our involvement with national associations. These connections across State borders can help with multi-state programming/research efforts, tour development, and information collection; just to name a few.

Leadership Development: Have you been looking for an opportunity to express your current leadership skills or build upon them? As a member of Zeta Chapter, opportunities are available to be active as an officer or participate on one or more of the chapter committees as a member or leader. There are numerous opportunities for you to grow as a leader.

Professional Development: Employees with Colorado State University Extension are expected to attend continuing education annually. Each year, Zeta Chapter, national ESP, and JCEP all offer continuing education opportunities to their members. Many of these Professional Improvement Conferences (PIC) offer subject matter and off-site workshops or industry related tours. Zeta Chapter History: Songs and Ruby Awards

Did you know that ESP made an effort in 1933-1934 to have an "Official Song"? According to the 1933 ESP Yearbook, the GREETING SONG for Epsilon Sigma Phi was presented by the Alpha Sigma Chapter at the Chicago meeting of the Eighth Annual Grand Council (1933). Words and music were written by T. L. Bewick, the Boys' and Girls' Club Leader for Wisconsin. The lyrics of the first verse are:

When we gather in friendly communion, Let's salute Epsilon Sigma Phi, With a song that may weld into union, A friendship that never will die, For we know when signing together, All the clouds disappear from the sky, So let's sing tho' it's stormy the weather, Hail to Thee Epsilon Sigma Phi.

In 1934, this lead to ESP Grand Council offering a prize of \$10 for the best song with original words composed by a member of ESP that could be adapted for Chapters and Grand Council meetings. In researching the Yearbook for minutes of the 1934 Grand Council, there was no mention of any awards for ESP Official Songs being submitted. Apparently, ESP Members are not songwriters, but rather focus on their work for improvement of farms and families.

In other historical news, the regulations that govern awarding the Distinguished Ruby Award were approved at the Ninth Annual Grand Council. Not more than one Ruby Award shall be conferred in any year except by unanimous vote of the delegates, and then only two awards at the most may be given. The voting process was quite extensive with nominations eligible to be submitted by all Chapters. After several votes and elimination, the name of the nominee with the most first-place votes then was submitted for final vote which must be unanimous.

ESP Life Membership is Tops!

If you retired in 2022 or are planning to in the near future, you can remain an active member of ESP by paying Life Member dues (\$275). Life Members are a welcome (and needed!) addition to our Zeta Chapter, and you can continue to serve on national committees as an officer, committee chair, or committee member. You can present at National ESP conferences, receive a stipend as a committee member, or receive a significant discount on the National Conference full registration fee.

Life Membership is paid ONCE (\$275). For Colorado, you send your \$275 to Zeta Chapter Treasurer Gus Westerman who sends it to National. The Life Member National Conference Registration has been reduced by \$200 each year so it almost pays for itself in one year. The 2023 National Conference is in Billings Montana September 24 to 28. Due February 1st

- <u>Community Engagement Scholarship Awards</u>
- Award Categories: Distinguished Community Engagement Scholarship Award and Emerging Community Engagement Scholarship Award
- Winner of the Distinguished Community Engagement is expected to be eligible and compete for national awards: C. Peter Magrath Community Engagement Scholarship Award, Engagement Scholarship Consortium Excellence Awards, and the APLU Innovation and Economic Prosperity University Awards

Due September 11th

- <u>Professional Development Award</u> CSU Commitment to Campus Professional Development (C2C)
- CSU Administrative Professional or State Classified

Due September 30th

- Distinguished Service Awards
- Link is emailed in September
- F.A. Anderson Award: Those eligible are state or regional CSU Extension personnel whose primary area of responsibility and achievement is at the statewide level. Previous winners of this award are not eligible for a second award for five years.
